1. ACCEPTANCE OF TERMS

The following terms and conditions ("Agreement") govern all use of the www.perryhallcraftfair.org website (the "Website") and the services and software available on or through the Website (the "Website", services and software shall be referred to collectively as the "Service"). The Service is owned and operated by Success & Niche LLC. The Service is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies and procedures that may be published from time to time on the Website by Success & Niche LLC. BY USING OR ACCESSING ANY PART OF THE SERVICE, YOU AGREE TO ALL OF THE TERMS AND CONDITIONS CONTAINED HEREIN; IF YOU DO NOT AGREE TO ANY OF SUCH TERMS AND CONDITIONS, DO NOT USE OR ACCESS THE SERVICE. This Agreement applies to you and your use of the Service regardless of whether you are a Seller, Buyer or other user of the Service.

PerryHallCraftFair.org is an e-commerce website that allows people to buy and sell goods within a fixed-price format. Success & Niche LLC takes steps to ensure that products sold on the Website are primarily AMERICAN handmade products.

HOWEVER, Success & Niche LLC is not directly involved in the transaction between buyers and sellers.

Consequently, Success & Niche LLC does not transfer legal ownership of items from the seller to the buyer. As a result, Success & Niche LLC does not control the quality, safety, morality or legality of any products sold on the Website; and Success & Niche LLC cannot verify the truth or accuracy of the listings, the ability of sellers to sell items or the ability of buyers to pay for items. Success & Niche LLC does not pre-screen users, specific information about products being offered for sale, or the products themselves sold on perryhallcraftfair.org.

Success & Niche LLC cannot guarantee the true identity, age, and nationality of a user. Success & Niche LLC cannot ensure that a buyer or seller will actually complete a transaction. For these reasons, buyers and sellers use the Service solely at their own risk.

By using the Service, you agree that Success & Niche LLC is not responsible or liable for content uploaded by users of the Service (such as data, text, information, usernames, graphics, images, photographs, profiles, audio, video, items, and links) or the products sold on the Website.

Success & Niche LLC encourages you to communicate directly with potential transaction partners through the tools available on the Website.
