## Introduction

Perry Hall High School PTSA (PHHS PTSA) is strongly committed to protecting the privacy of its sellers and visitors to [perryhallcraftfair.org](http://perryhallcraftfair.org). This privacy policy describes what information PHHS PTSA may collect from its sellers and visitors and how we may use that information once it is collected.

## To what Websites Does This Policy Apply?

This privacy policy applies to the website located at [www.perryhallcraftfair.org](http://www.perryhallcraftfair.org) (the "Website"). It does not apply to any other websites, including those that link to the Website or third-party websites that [perryhallcraftfair.org](http://perryhallcraftfair.org) links to. This policy does not apply to the practices of any third party, affiliate, or business partner that PHHS PTSA does not own or control.

## Privacy Policy Changes

PHHS PTSA reserves the right to change its privacy policy at any time without prior notice. Any changes to the privacy policy will be posted on this page and will be effective immediately upon posting.

## Collection of Non-Personal Data

If you browse the Website, you do so anonymously. We do not collect your e-mail address or other personal information.

## Collection and Use of Your Personal Information

Except as specified in this policy, PHHS PTSA will not sell or disclose your name, email address or other personal information to third parties without your explicit consent.

PHHS PTSA collects certain information about you in order to allow your account to function properly, to enable you to make purchases and complete transactions with third parties on the Website. At any time, you may log in and change this information, or remove it.

Although we reserve the right to monitor the type of products you offer for sale on the Website, sales volumes, product description and sales content information and response data from time to time to make sure they comply with our Terms & Conditions, we will never share, sell or rent your information or email address to anyone for any reason.

As part of the buying and selling process, PHHS PTSA will share information between the two parties involved in the transaction on [perryhallcraftfair.org](http://perryhallcraftfair.org). You may obtain another [perryhallcraftfair.org](http://perryhallcraftfair.org) party's email address, shipping address, payment information, and/or other information. As described in [PerryHallCraftFair.org](http://PerryHallCraftFair.org)'s Terms of Use, you have a limited license to use this information only for [perryhallcraftfair.org](http://perryhallcraftfair.org)-related communications or for [perryhallcraftfair.org](http://perryhallcraftfair.org)-facilitated transactions. PHHS PTSA has not granted you a license to use the information for unsolicited commercial messages. Without express consent from that person, you must not add any [perryhallcraftfair.org](http://perryhallcraftfair.org) party to your email or physical mailing list.

Your username, perryhallcraftfair.org ID or alias is publicly displayed and connected to your perryhallcraftfair.org activity. Other people may see your feedback, ratings, profile information, items listed for sale, shop pages, sold item listings, and comments in community spaces.

Some members or visitors may connect to or register a perryhallcraftfair.org account using an external third-party application, such as Facebook. Connecting your perryhallcraftfair.org account to third-party applications or services is optional. You may optionally choose to provide your full name and other personal information to be publicly displayed in connection to your account and activity.

If you have optionally connected your account to an external, third-party application, such as Facebook, you can remove permission for the app by changing your account settings.

## Disclosure of Your Personal Information

PHHS PTSA may release your personal information to a third-party to (a) comply with a subpoena or other similar legal procedure; (b) defend the rights of PHHS PTSA or its affiliates or business partners; (c) protect the personal or financial safety of PHHS PTSA officers, agents, affiliates, business partners, customers or Website users; (d) when we believe in good faith that such disclosure is necessary to comply with the law; or (e) investigate or take action regarding illegal activities, suspected fraud, or violations of perryhallcraftfair.org's Terms of Use. We may disclose personally identifiable information to parties in compliance with our Copyright and Intellectual Property Policy, as we in our sole discretion believe necessary or appropriate in connection with an investigation of fraud, intellectual property infringement, piracy, or other unlawful activity. In such events, PHHS PTSA may disclose name, address, country, phone number, email address and company name.

## Third-Party Services

PHHS PTSA may employ other companies and people to perform tasks on our behalf, and we may need to share your information with them to provide products and services to you. Examples include but are not limited to fulfilling orders, processing payments, handling billing disputes and collections, analyzing data, providing marketing assistance and providing customer service. PHHS PTSA may partner with third-party services for fraud prevention and/or identity verification.

PHHS PTSA is affiliated with a variety of businesses, some of which may offer promotions or sell items or services to you independently or jointly with PHHS PTSA through the Website. We may share information (including aggregated demographic information) that is related to such transaction with that affiliated business.

The Website may offer features and services administered or provided by third parties hired by PHHS PTSA. To receive these services, you may be required to provide these third parties with personal information. All such services are subject to separate terms and conditions established by our third-party providers, including separate privacy policies, which may be different than this privacy policy. When you load a page on perryhallcraftfair.org that has a social plug-in from a third-party site or service, such as a Like or Send button, you are also loading content from that third-party site. That site may request cookies directly from your browser. These interactions are subject to the privacy policy of the third-party site.

## Security & Secure Billing Transactions

You are asked to supply certain personal information in order to pay your perryhallcraftfair.org service charges. That information is transferred, using secure transmission technology to a trusted third party for processing. The information is then encrypted and securely stored to handle your transactions.

Except for payment transactions, the Website does not use a secure server to transmit data to and from our site. Be sure not to transmit any credit card or other financial or sensitive data through this website

unless you have first verified that the data is being submitted to our third-party service provider's secure server.

## Messages From PHHS PTSA

PHHS PTSA may send you messages related to certain features on perryhallcraftfair.org or your activity. PHHS PTSA may also send you news or updates about changes to our site or services. By default, parties will receive these messages via email, but you may choose to opt-out of getting certain emails under your account settings.

PHHS PTSA may offer email newsletters. You must opt-in or subscribe to begin receiving newsletters. You may subscribe or unsubscribe from optional newsletters under your account settings or by following the instructions contained in the newsletter emails. Non-members may subscribe by providing an email address, which will only be used by PHHS PTSA for these newsletters. Non-members may unsubscribe from newsletters by following the instructions contained in the newsletter emails.

## Data Retention

PHHS PTSA will retain your information for as long as your account is active or as needed to provide you services. If you no longer want PHHS PTSA to use your information to provide you services, you may close your account. PHHS PTSA will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

## Removing or Updating Personal Information

You may change or correct your PHHS PTSA account information (except your username) at any time. You may remove certain optional information you no longer wish to be publicly visible.

## Governing Law and Jurisdiction

Any disputes arising out of this Policy shall be adjudicated in a court of competent jurisdiction in Baltimore County, Maryland.
